1. The Ramp Pass season starts May 1 and ends September 30th.
 2. This contract applies only to the vessel listed above, is nontransferable and nonrefundable. No Exceptions
 3. All keys must be returned by September 30th or a \$50.00 fee will be charged.
 4. A key will be issued and will be your responsibility to lock the building and/or ramp after each use.
 5. Spring Brook Marine is not responsible for any damages, theft, or any items left in building during this period.
 6. Authorization of the ramp or building to a non-key holder will result in privileges revoked with no refund.
 7. Vehicle and trailer parking is South of #7 building ONLY; any vehicle/trailer will be towed at the owner's expense.
 8. Place ramp sticker on the front left side of the trailer tongue for easy viewing.
 9. This contract does not include overnight dockage.
 10. Each party is required to provide Spring Brook Marine with a certificate of insurance.
 11. No trailer is to be locked inside the buildings-Spring Brook Marine reserves the right to relocate boat.
 12. Noise and language shall be kept to a minimum at all times. Tenant shall use discretion in operating engines, radios, etc.,
 13. No insurance is carried by Spring Brook Marine on customer owned boats and/or property. This contract is accepted at the sole risk of the owner who hereby releases Spring Brook Marine from all claims of loss or damage however caused.
 14. Any infraction of the terms and conditions hereof or of the rules and regulations of the Marina by the Tenant shall, at the option of the Marina, render this contract cancel-able and the Tenant shall forthwith remove his/her boat without refund.
