GENERAL MARINA RULES AND REGULATIONS:

1. The word "Marina" is used here to indicate any person authorized to represent Spring Brook Marine. The word "Tenant" is used here to indicate the owner (or his authorized representative) of any boat moored at Spring Brook Marine.
2. This lease is non-transferable and is valid for dock and RV space from April 1 thru October 31 and for Ramp Pass and trailer storage is May 1 thru September 30. No refunds. No exceptions.
3. To be admitted and to continue as a Tenant of the Marina, a property must be:
 - a. Used for pleasure only;
 - b. Registered, identified, marked, equipped and maintained as required by law and safe practice;
 - c. Subject to periodic inspection by the Marina to determine the maintenance of proper safety conditions.
4. No insurance is carried by Spring Brook Marine on customer owned boats or other property. Therefore, is contracted accepted at the sole risk of the owner who hereby releases Spring Brook Marine from any and all claims for loss or damage however caused. The Tenant agrees to have proof of insurance with complete Marina coverage including liability. Each Tenant is responsible for damages he or his guests may cause to other property in the Marina or to any structures of the facilities thereof.
5. All property shall be secured in their spaces in a manner acceptable to the Marina, or the Marina will adequately secure the property at the Tenant's expense.
6. Any owner whose vessel is sold during the term of this contract, even without the efforts of Marina Personnel, will be assessed a 10% fee of actual selling price.
7. Any infraction of the terms and conditions hereof or of the rules and regulations of the Marina by the Tenant shall, at the option of the Marina, render this contract cancel-able and the Tenant shall forthwith remove his/her boat without refund.
8. In any event of severe storm or flood the Marina will attempt, if practicable and possible to provide preparation and damage protection service, the cost for which will be born by the Tenant. However, the Tenant is still solely responsible to take all emergency measures possible, and the Marina does not assume any responsibility for said protection and/or damages to the Tenant's property.

9. All reasonable precautions will be taken by the Marina to ensure the Tenant's property and safety. However, the Marina assumes no responsibility for the safety of any piece of property in the Marina and will not be liable for fire, theft or damage to said property, its equipment, or any property in on and or around however arising.
10. The Tenant shall provide the Marina with the location of a main door key, hatch and ignition keys for emergency service.
11. If you do not Dry Dock at Spring Brook Marine you will not be eligible for the same space, and/or anyone having any invoices over 30 days past due will not be eligible for launching or the following years space.
12. The Tenant (and guests for who he is responsible) agrees to conduct himself at all times when on the property of the Marina, so as to create no annoyance, hazard or nuisance to the property or to other Tenants. This involves observance of good housekeeping and sanitation practices.
13. No mounts to be attached to docks or any other marina property (No Exceptions)
14. For safety and insurance measures NO outside labor will be allowed on Marina property.
15. In the event of an emergency during the Tenant's absence, the Marina is authorized to make necessary repairs which will be charged to the Tenant.
16. Any condition on the tenants property, in the opinion of the Marina, constitutes a fire hazard or a health nuisance or danger to public safety, must be corrected immediately by the owner.
17. NO oil or inflammable liquids shall be thrown, pumped overboard or disposed in refuse containers. Garbage must be deposited in receptacles supplied for that purpose.
18. Tenant shall not store supplies, materials, accessories, or debris on any walkway, and shall not construct thereon any lockers, chests, cabinets, or similar structure. Painting, scraping, or repairing of gear on vessels is not permitted on piers.
19. Noise and language shall be kept to a minimum at all times. Tenant shall use discretion in operating engines, generators, radios, and television sets, so as not to create a disturbance.
20. Swimming or diving is not permitted from the piers or boats in the harbor.
21. Laundry shall not be hung out on any structures around the Marina.
22. Neither "for sale" signs nor other signs may be posted on any marina property. No exceptions.
23. The entire Marina facility including the gas dock is considered a NO WAKE AREA. The vessel owner shall be responsible for any and all damage incurred.
24. All boats docked in the Marina shall observe and comply with all health and sanitary regulations governing the waterways.
25. Any person causing injury or damage to other persons property shall be liable thereof, and violations of Marina rules, disorder, depredations, or indecorous conduct by a Tenant or guests that may injure a person, cause damage to property or harm the reputation of the Marina is just cause for immediate removal of the tenants property in question from the premises.
26. All dogs must be kept on a leash, and pets shall be controlled to insure peace and privacy of other Marina tenants. Owners shall be responsible for the sanitation concerns of their pets.
27. All small children are to wear life jackets on docks or near the water.
28. Absolutely no running on the docks & No throwing of stones.
29. For safety reasons NO fueling is allowed at the docks. No carrying or transferring of fuel. No exceptions.
30. NO electric cords to be left plugged in dockside when not on boat. NO air/heat units may be left on while not on board.
31. If air conditioning is added during this contract period, it is the owner's responsibility to report it for adjustment in billing.
32. Absolutely NO grill cooking on docks or boats whether fueled by charcoal, propane, alcohol, electric, or any other source.
33. A 5 mile speed limit on road will be enforced. Please abide.
34. Put your name on your cradle and/or trailer. We are not responsible for your framing, canvas, trailer or possessions, etc.
35. All boats must have a polarity indicator.
36. A service charge of 5% per month will be applied to all invoices over 30 days.
37. Please help keep wash rooms clean. Turn off lights when leaving, etc.
38. No unauthorized motor homes, motor scooters, dirt bikes, ATV's, campers, golf carts, etc. will be allowed. Contract will be terminated.
39. Spring Brook Marine is not responsible for any missing items, personal property, grills, chairs, cords, etc.
40. If a delivery captain is requested or a mechanic is hired to perform service repairs the customer agrees to release and discharge Spring Brook Marine and/or the delivery captain/mechanic from any and all claims, damages, suits or causes of action of any kind or nature arising out of any accident or other occurrence.
41. All building and ramp keys must be returned by Sept. 30 or a \$50.00 fee will be charged.
42. Authorization for the use of the ramp, dock or building to a non-member will result in privileges revoked with no refund.
43. This contract applies only to the vessel listed on the contract.
